



SKYRIDGE GLAMPING LTD. - Hotel Policies & Waiver

RESERVATIONS/CANCELLATIONS/CHANGES

The resort accepts bookings as a **non-refundable pre-paid reservations** and as **flexible non-pre-paid reservation**. Bookings can only be made with a credit card. Check in time is 4pm and check out is 11am.

For non-refundable pre-paid reservations full payment must be paid by credit card at time of booking. The booking cannot be cancelled or changed. After 48 hr grace period, the booking becomes 100% non-refundable.

For flexible non-pre-paid reservations full payment must be paid by credit card 72 hours prior to check-in. The booking can be cancelled or changed up to 72 hours prior to check-in at no cost to the Guest.

Within 72 hours of check-in, the booking becomes 100% non-refundable.

All bookings made within 72 hrs prior to check-in are considered 100% non-refundable.

No show bookings will be charged full reservation room and tax charges.

VIRTUAL CHECK-IN

Check-in time is any time after 4 pm. We do not provide early check-ins or late check-outs. Enjoy a hassle-free stay with our virtual check in. 72 Hours prior to arrival you will receive an email and/or SMS message with a link to complete your check-in. This must be completed in full. You will also be required to upload your ID and update credit card information (if needed).

KEY LOCK CODE

72 Hrs before check-in, and your registration link has been completed in full, we will email you your room number and personalized key lock code. You will need this code to enter your unit as there is no physical key. If you choose not to complete our on-line virtual check-in our front desk is available 24/7 at Skyridge Glamping and our Guest Services staff will gladly get you checked in. We will require your credit card for payment and ID at that time.

HOUSEKEEPING

We provide daily housekeeping on request only and/or Nightly turndown service for a fee. We provide turn over service for longer stays. Minimum turn over/housekeeping service every 3 nights.

PET POLICY

Skyridge Glamping Ltd. has specific pet-friendly units. There are no pets allowed in non-pet-friendly rooms. A fine of \$250/stay will incur for any pets found in non-pet-friendly rooms.

NON-SMOKING & VAPING

Skyridge Glamping Ltd. is non-smoking & vaping. There will be a \$250 fine if evidence of any guests found smoking or vaping in their unit or on any of the balconies. No smoking outside within 15' of any door or window.



QUIET HOURS

Quiet hours are from 10:00pm to 7:00am. Please respect all guests by keeping noise to a minimum. We have a strict one warning rule. We reserve the right to fine for any noise violations on the second offense. We have systems in place to notify the Front Desk of any instances where the noise exceeds an acceptable threshold for volume and time.

PARKING

Skyridge Glamping has limited parking space. One parking stall per unit is available. There is additional parking available in front of check-in office.

Each room reservation includes one complimentary parking stall. Unauthorized or additional vehicles will be fined and towed. No large trailers / RV's permitted

CCTV

Skyridge Glamping Ltd. has installed video recording technology in public locations, such as lobbies, walkways, and parking areas, for the safety of its employees and visitors.

DRONES NOT ALLOWED

Skyridge Glamping Ltd. grounds are within Provincial Park where Alberta Parks prohibits the use of UAVs for recreational use. Commercial pilots would require a permit. [Read more.](#)
